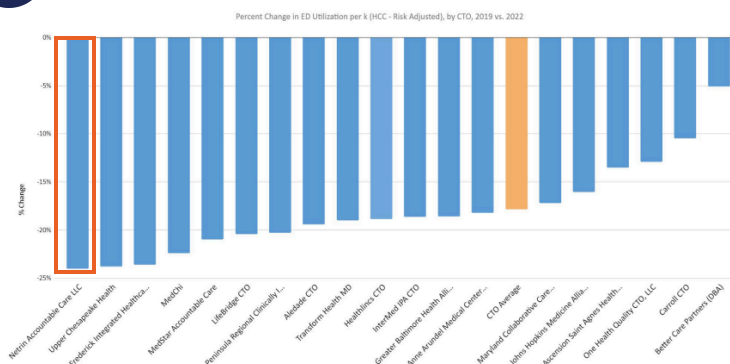

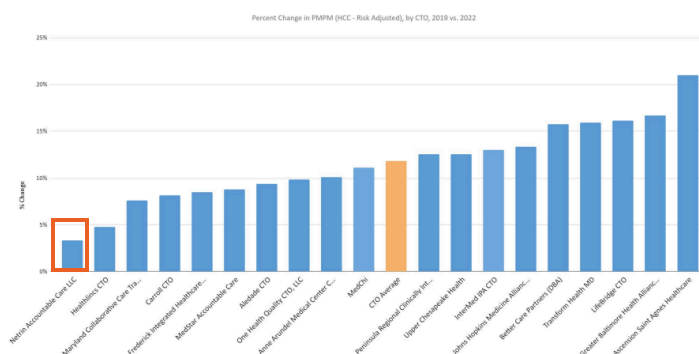
1 Emergency Department Utilization Per K 2019 to 2022



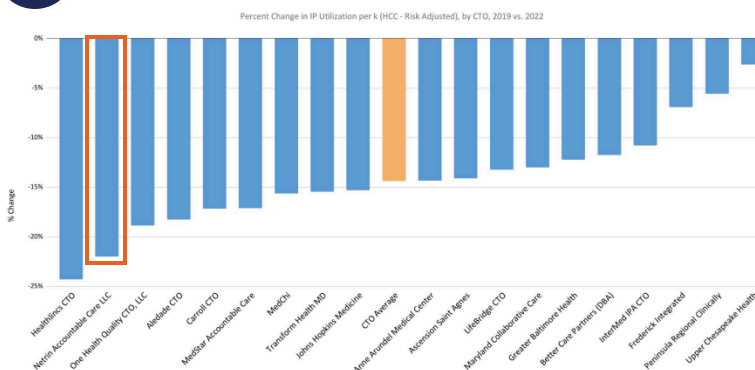

2 Total Per beneficiary Per Month (PBPM) 2019 to 2022



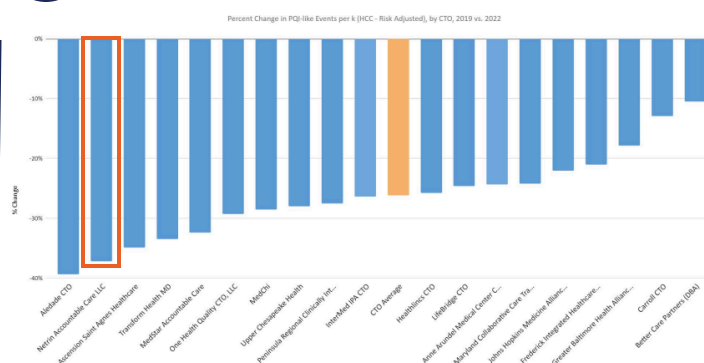
3 Inpatient Utilization Utilization Per K 2019 to 2022
